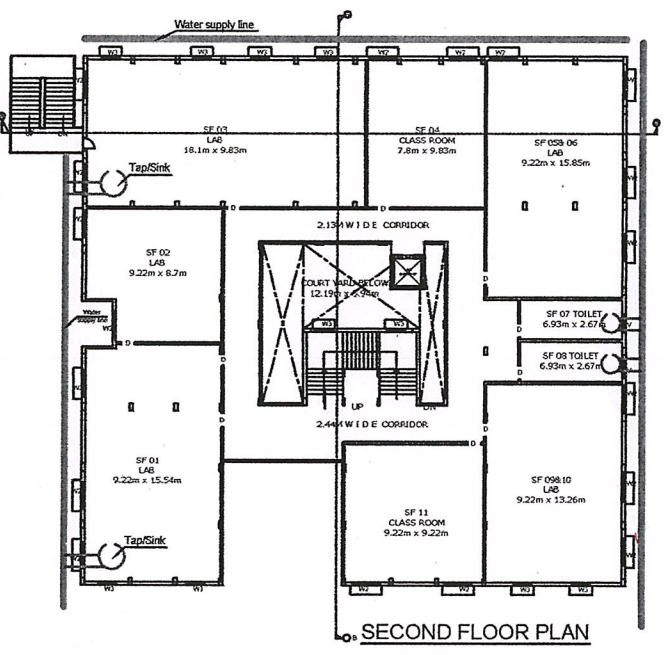
FIRST FLOOR PLAN
