

## 4. The Practice:



### 2. Objectives of the Practice:

Objective of the Programme: Geethanjali college of Pharmacy (GCPK) is devoted to include Community Service as a special programme in National Pharmacy week, as education beyond classroom to make IPA and NSS student volunteers gain challenging and electrifying real-world experiences. The practice in vogue for the last five years provides community services like Breast cancer screening camp, COVID-19 awareness programme, campaign for awareness on responsible use of medicine to the Cheeryal villagers on National Pharmacy week Occasion under the supervision and guidance of Dr. M.Ravi Kumar, Professor& Principal and faculty members of the institution.

The Key Practice makes villagers to understand:

- Awareness programmes on Communicable and Non-Communicable diseases and their treatment at Cheeryal village.
- Medical campus like Breast cancer screening, eye checkup, and Blood donation camp.
- ➤ Make them health conscious.

## 3. The Context:

The people of the Cheeryal village are not well educated and hence do not know about prevention and treatment of various Communicable and Non-Communicable diseases. They fail to maintain the proper hygienic conditions that might raise various health issues. Women related issues like menstrual hygiene, reproductive diseases, breast cancer and cervical cancer etc., have become the concern of the day.

# 4. The Practice:

A special one week programme is implemented where students of the institution visit Cheeryal village the practice is being followed from 2015 and continued till the announcement of lockdown. Students are segregated in to different groups, each group of 6 or 7 members visit the allotted streets of Cheeryal village and counsel the public for their ailments, assist in prescription handling and guide them on proper usage of medicines as per the given prescription and guiding role of pharmacists is taken up by the students. Clinical examinations, tests for Diabetes, Hypertension, Obesity, Blood Grouping, Hb estimation, Body Mass Index, monitoring and carry out breastscreening tests for the villagers with the support of MNJcancer hosipital, Hyderabad. In addition, patients are counselled for injuries, first-aid in case of accidents, pesticide poisoning, snake, dog and insect bites, respiratory diseases, gastric

problems, and depression among women. It is ensured that all the patients are attended to and counselled. Students as budding pharmacists check prescriptions before dispensing the medicine and ensure that the patients do not receive the wrong drugs and also guide them on the dosage. They are also informed about the drug interactions. The college has made it an inclusive and customary practice to offer curative, preventive and promotive medical counseling services to the Cheeryal villagers as it plays a major role in transforming a student into a responsible citizen. Students learn compassion and empathy during clinical work which will further lead them into quality professional lives to derive at the best possible patient experience. Working under the guidance of health professionals, students learn to apply the learned concepts in a patient centred environment.
